We need to increase and multiply.


I am looking into several new pins for this year and hope to have them by Tomb Trek. As



### From the Supreme Surgeon

### **PTSD**

he recent events in Afghanistan may have triggered a PTSD event in many of our fellow Veterans. It is important to raise your awareness of PTSD and how to help the Veteran.

 According to the CDC, people with PTSD may rehash past events, fight against sleeplessness, feel nauseous and can be easily startled. They can also experience uncontrollable shaking, heart palpations and headaches. Additionally, people with severe forms of PTSD may experience challenges in social settings, at home and work.



- While It may be difficult to interact with someone with PTSD, it
  is important to know this person is having a tough time if not more. The nervous system of someone
  with PTSD is especially vulnerable, which may lead to feelings of anger, irritability, untrusting and
  being on high alert. A supportive social circle is the best way to calm him or her down.
- 3. Face-to-face support will help a PTSD person better than care from afar. This support can come in the form of pleasurable hobbies, rhythmic exercises and/or lunch dates.
- 4. The National Institute of Mental Health says it can become difficult to understand someone with PTSD. Their lack of affection, volatile behavior, excessive irritability and paranoia can make you feel like a total stranger. However, understanding the symptoms of PTSD and remembering that the person may have limited awareness of their behavior are the first steps in creating an effective support system.
- 5. Those affected with PTSD have a hard time opening up and expressing their feelings. Do not push them to talk. Be that sounding board that they need and allow them to open up at their own pace.
- Flashbacks and nightmares from a traumatic event are a common symptom of PTSD. Deep breathing exercises, Yoga and professional counseling and therapy can help deal with distress and anxiety.
- 7. Situations, places, things, sounds and sights can trigger PTSD symptoms. People with combat related PTSD tend to be irritable and prone to sudden outburst of anger. Don't engage them while they are in this state. Have a plan to deal with these impulses and develop healthy coping skills to stay calm.

PTSD comes with a potential risk of secondary trauma for the caregiver. Remember that managing your own stress is just as important as caring of your partner. Professional therapy can help both you and the person with PTSD cope and heal.

#### September 2021

- 1. Having been duly elected by the Council of Administration, I, Olin Parks, hereby assume command of the Military Order of the Cootie of the United States. All previous Supreme appointments have now expired. Cooties will now revert to their previous and proper tassels.
- 2. Notice is hereby given that the logo, bug, official seal, hat and the name Military Order of the Cootie are trademarked and copyrighted property of the Supreme Pup Tent, Military Order of the Cootie of the United States and may not be used without the express written consent of the Supreme Pup Tent. Violators of this order will be prosecuted to the fullest extent of the law.
- Supreme Headquarters is established as being located at 604 Braddock Ave., Turtle Creek, PA 15145. Office hours at Supreme Headquarters are from 9 am to 5 pm Monday through Friday, Eastern Time. Supreme Headquarters, MOC is closed for all Federal Holidays.
- 4. The Supreme Budget was approved by the Supreme Council of Administration on 7 August 2021.
- 5. In accordance with Supreme Policy, all Grands are to inform Supreme Headquarters of the dates and places of any Grand Events so that proper representation may be assigned. Supreme Representations for Grand Events Forms are to be mailed to Supreme Adjutant Tracy Woodman, 1916 Grumann Dr, Tomah, WI 54660 or emailed to cootieworker-calendar@yahoo.com
- 6. Grands are reminded to forward a copy of each of their General Orders to the Supreme Adjutant.

- 11. Supreme ended the year at 94.83% inspected. Grand Inspectors need to start your inspections now and finish early. As of 31 August 2021, we have 2.58% reported as inspected. Send reports to Supreme Inspector T. Earl Bigham. Don't hold on to them; send them as you finish each one.
- 12. Each Cootie will be assessed \$2.00: \$1.00 for the Supreme Commander's Special Project (Activity Equipment for the children at the National Home) and \$1.00 for the National Home MOC/MOCA House maintenance fee.
- 13. Pup Tents, Districts, Grands and Auxiliaries are reminded that they are to file IRS Form 990 within five months and fifteen days of the close of their fiscal year. Units whose income for 2020 was less than \$50,000.00 can elect to file Form 990-N, an

electronic informational return instead of a paper return. Those units whose income was over \$50,000.00 will still have to file the regular Form 990 or 990T.

- 14. Reporting for all programs are due to their respective chairman no later than 31 May 2022.
- 15. 2021-2022 Supreme Policy was approved by the Council of Administration and is in effect.

#### MOC SUPREME GENERAL ORDER 2021-2022: #2

#### 13 September 2021

- Past Department Commander/Past Grand Commander from Colorado Steve Rylant passed earlier this month. Those wishing to send cards of condolences can send them to: Colleen Rylant & family, 130 E. 22<sup>nd</sup> St, Loveland, Colorado 80538.
- 2. Grand Events: Please send Supreme Adjutant the dates of your Grand Events at <u>cootieworker-</u> <u>calendar@yahoo.com</u>. Also please send your request for Supreme Representation.
- 3. Supreme By-Laws: Grand Commanders when you receive the updated 2021 Supreme By-Laws, it is your responsibility to forward them to your officers, Pup Tent Supreme Squirrels and CCDBs.
- 4. Section 435 Arrearages: (from Bylaws Manual) "A Grand Pup Tent in arrears, reports, per capita tax payments, supply money, or financial obligations shall be deprived of all representation at the Supreme Scratch until same are paid to the proper responsibility." Remember Grand Commanders are now Council of Administration members!!
- 5. Section 308: B. "The installing officer shall forward immediately after installation, a report, properly signed to the Supreme Adjutant and to the Grand Adjutant where a Grand Pup Tent exists." Essentially the same process is to be followed for Grand installations and reporting.

## MOC General Order #3 2027-2022

#### MOC SUPREME GENERAL ORDER 2021-2022: #3

20 September 2021

- 1. Pursuant to Section 505C of the Supreme Bylaws, the Supreme Districts are disbanded and will meet only to determine the disposition of funds and assets and to settle any obligations.
- 2. The terms of all current Supreme Councilmembers will come to an end and pursuant to Section 529, these officers will be recognized as Past Supreme Councilmembers in the Military Order of the Cootie with all the rights and privileges pertaining thereto.
- 3. All Supreme Districts must have all monies and assets dissolved and all obligations settled not later than December 31, 2021. Pursuant to federal law all Districts utilizing an EIN will be required to submit a close out or final IRS form 990 to the Internal Revenue Service for 2021. Any monies or assets remaining after December 31, 2021, will be turned over to the Supreme Pup Tent Quartermaster. All decisions as to the disposition of funds and assets shall be decided by vote of the members of the Supreme District. If the members of the Supreme District do not meet to decide these matters by vote, all monies and assets will be turned over to the Supreme Quartermaster. All meeting minutes from 2020 and 2021, the minutes of the meeting deciding the disposition of funds and assets, all bank statements from 2020 and 2021, and any items of historical value must be submitted to the Supreme Adjutant. The Supreme Councilmember in office prior to this order is responsible to carry out these duties.
- 4. Pursuant to Section 505D, the two newly created regions (East and West) will meet at a time and method to be determined for the purpose of developing a rotational schedule to determine which Black Division Pup Tent is next in line to serve as the Supreme Councilmember for their respective Region. Additionally, and pursuant to Section 505E, each region shall elect a Vice Councilmember for a term to run concurrent with the Supreme Council of Administration member. The duties of such officers will be to provide representation on the Supreme Council of Administration, to provide administrative oversight of the region's separate Pup Tents, advice, counsel, training as required by the Supreme Pup Tent, and any other duties incidental to the office. Each

- 5. The East and West Regions will not have elected or appointed officers other than the Councilmember and the Vice Councilmember. The Regions will not hold, collect, or distribute funds of any type nor will the Regions create an EIN.
- 6. All Black Division Pup Tents located East of the Mississippi River will meet by Zoom call on 28 September 2021, chaired by Supreme Sr. Vice Commander, Dwight Hora, to establish the councilmember rotation, to elect their Councilmember and Vice Councilmember.
- 7. All Black Division Pup Tents located West of the Mississippi River will meet by Zoom call on 28 September 2021 chaired by Supreme Jr. Vice Commander, Mark Larkin, to establish the councilmember rotation, to elect their Councilmember and Vice Councilmember.
- 8. As of the date of this order, all Grand Commanders/Seam Squirrels will assume their role as members of the Supreme Council of administration

with all the rights and responsibilities pertaining to the office. Grand Commanders are entitled to purchase item #220, Double Sided Grand Commander Hat with Supreme Councilmember on the other side from the Cootie Depot. However, the tassels and buttons the officer chooses to wear must correspond with the side facing forward.

- 9. Leaders of the organization are reminded of changes made to the conduct of scratches at all levels pursuant to Sections 213, 405A, 425, and 503, which allow for the integration of technology. As a reminder, this is not intended to be a mandate rather than providing a path for it to be permitted. Units must also develop additional written procedures for the conduct of such meetings before technology can be utilized.
- 10. All officers of the organization are encouraged to become familiar with the changes to the Supreme Bylaws approved at the 102d Supreme Scratch in Kansas City and ratified by the Veterans of Foreign Wars on September 1, 2021.



GaGa (literally 'touch-touch' in Hebrew) is a variant of dodge-ball that is played with one ball. GaGa Ball is thought to have originated in Israel. GaGa's popularity has continued to rise in the US and is extremely popular at camps, schools, and playgrounds everywhere.



### How do you play Gaga Ball?



### WAS IT ALL A WASTE?

n April 14, 2021, President Biden announced the full withdrawal of U.S. Forces from Afghanistan by September 11, 2021 – the anniversary of the terrorist attacks 20 years earlier. This announcement was considered long-overdue by some, but foolhardy by others.

But among those who have borne the burden of the fight – and have been wounded or lost their closest friends, the response may be somewhat different. As the Veterans of America's longest war see images of empty base camps on the news and hear reports of the Taliban doing terrible things again, they may be asking these questions. "Was it all a waste?" "Were all those sacrifices in vain?" "Did they accomplish nothing?" "Will the ground we fought so hard to gain and the objectives we sacrificed so much for be lost?"

I'm sure that many Soldiers welcome a respite from combat duty. They'll have little grief over one less opportunity to deploy. However, lingering in the minds of all Soldiers is the fear that they might have to go back there in years to come and retake everything that was lost.

I'd like to speak for a few moments to those who feel some fear and anguish over our withdrawal from Afghanistan. Let's begin by putting things in perspective. First, many of the objectives of the War in Afghanistan were definitely met. As one member of the Scowcroft Center for Strategy and Security stated, "Al Qaeda was evicted, the 2001 Taliban government was smashed, and Washington made the point that no one attacks the United States with impunity." Osama bin Laden, who started the war, was put on the run and killed. The goals in Afghanistan have certainly been expanded over the years, but the purposes of keeping pressure on the Taliban and stabilizing the government in neighboring Pakistan were well-served and successful.

Second, let's understand the nature of the military's mission. It's on-going and never-ending. Just as the human body's immune system must wage a never-ending war against invading pathogens, so the military must continually fight for the health and survival of our nation. Yes, the immune system that killed one infection and brought health back to the body, will have to fight the same battle again. But that's the nature of the job. It's a ceaseless vigil.

True, the mess that we cleaned up in one country, will get messed up again. But there are many tasks that share this disadvantage. Do you remember the computer animated superhero, Mr. Incredible? In the 2004 movie Mr. Incredible made a profound point about his job. "No matter how many times you save the world, it always manages to get in jeopardy again. Sometimes I just want it to 'stay saved' – you know - for a little bit. I feel like the maid sometimes. 'I just cleaned up this mess, can we keep it clean – for ten minutes?'" Superman would agree that it's a never-ending battle for truth, justice, and the American way.

In a very real way, every Soldier, Sailor, Airman, Marine, and Coastguardsman is a superhero. They are forever answering the call to crush the oppression of the wicked. But it's an on-going battle that has no end. And the things you once fought hard to repair will become broken again. But don't ever view your efforts as a waste. It's the job that has to be done, repeatedly.

It's sort of like the difference between the workers who built the Golden Gate Bridge and the workers who must unceasingly work for its upkeep. The first crew had a clean-cut job which lasted only a few years. Some military operations are like that. But I suspect that most military missions parallel the work of the latter crew who never cease to repair, scrape, and re-paint the bridge. Their work will never end. Yet, without their labors rust and damage will inevitably take over and bring that bridge crashing down. In the same way, without the Soldier's unceasing efforts, freedom will come crashing down.

Third, don't forget the lesson you learned from your previous deployments. There are respites along the way. And you're not alone in the battle. And you are only responsible for your performance in the mission. Most deployments to Afghanistan involved relieving a unit in place, carrying on the mission for a year or nine months, and then passing it one to the next unit.

Yes, it's possible that the unit which followed yours might have dropped the ball and failed. But you are not responsible for their performance, only your own. Like a relay runner who neither begins nor finishes the race, you took the baton, ran your hardest, then successfully passed it on to the next runner. If you did this, then you were successful in your mission.

Apply this lesson to the War in Afghanistan. Every Soldier who fought and died in Afghanistan fulfilled their duty on the side of justice and freedom. They fought against terrorism and spent their lives in a worthy cause. And, particularly for the War in Afghanistan, those brave Soldiers took the fight from America's heartland to the home of our attackers. They brought the war to the doorstep of their enemies and prevented any further attacks like those which took place on September 11, 2001. Wasn't this a worthy cause?

Fourth, don't lose sight of the bigger picture and of the importance of your contribution. There's a temptation that comes with missions which are too large to grasp. Often our own pain and struggles can make us lose sight of the greater war that's going on and of the importance of our contribution. The mission is huge. It's the ages-long conflict between good and evil – a battle which good cannot afford to lose.

As an analogy, think of the great Gothic cathedrals of Europe. The cathedral of Notre Dame in Paris took 182 years to complete. This was during a period when the average Parisian had a life expectancy of only 45 years. This meant that a craftsman who began the massive project in 1160 had no hope of ever seeing his work completed – nor did his son or grandson. Each of them had to content himself that he was part of a team - a chronological team, a long succession of laborers. The mission was greater than any individual or any one generation. So, they had to take up the mission from their predecessor and build upon it. Then they had to entrust their gains on to a successor before closing their eyes in death. Yet, in every case, each generation's contribution was indispensable and integral to mission success.

The same is true in the awesome age-long battle between good and evil. Don't lose sight of the greater goal, nor of the destructive ramifications if we fail in our contribution.

Fifth, in this ages-long battle, there will always be the gaining and the giving of ground. There will always be battles lost and battles won. It will resemble a back and forth tug-o-war. But don't lose heart, for good must always put forth the effort. Even though our victories are interspersed with defeats, those victories are never nullified by the defeats.

As an analogy, think about some of the towering rock formations of the desert Southwest. Consider, for instance, the rock pinnacle named Lighthouse Peak, in the Palo Duro Canyon of the Texas Panhandle. This towering formation rises 3,100 feet above sea level. Its survival has depended on the extremely resistant layer of caliche (a very hard limestone) that caps its top and some other intermittent layers of hard limestone. But this sturdy formation consists mostly of soft mudstones and gypsum. Obviously, if the whole of Lighthouse Peak consisted of the brightly-colored mudstone and the white streaks of gypsum, it would have dissolved long ago. All would have quickly eroded away. But the presence of a few hard and weather-resistant layers make all the difference in the Lighthouse's survival. And the soft layers do not cancel out or nullify the hard ones.

Those few hard layers in Lighthouse Peak are like the few hard-fought victories of the good. The evil-resisting forces of good will keep the nation standing, despite the weaknesses of the evil. They'll uphold the world, regardless of the presence and successes of the corrosive forces of evil. It may look like the forces of evil will bring the world down – especially when they dominate history. But the costly and courageous efforts of the good will stabilize and save our world. They will never be nullified by any advances of evil.

And, finally, remember that all our wars should be viewed as battles in a far greater conflict.

Many would rather forget the painful struggles in Korea (33,000 American lives lost from 1950-1953) and Vietnam (58,000 lives lost from 1961-1973). But the true meaning of those conflicts lies in their relation to the greater Cold War. For without taking those stands against Soviet aggression, America would not have been victorious in the Cold War - which was considered by many un-winnable! Oh, yes, I recall many a critic telling me, "I'd rather be Red than dead." And they said this right up to the point the Soviet Union collapsed. They championed the cause of that evil empire right up to its downfall.

But they were wrong. Neither Korea, nor Vietnam, nor Afghanistan, nor Iraq were senseless wastes of manhood. In those battles, though some were lost, we have won the greater victory – the survival and success of our nation. We have brought the fight to the enemy's doorstep and proven our resolve to fight for what we believe.

In a way, the War in Afghanistan is like a single piece of a jigsaw puzzle. That piece of a puzzle is hard or impossible to understand when viewed as an isolated object. Its irregular shape and confusing color make no sense to us. But when it's viewed within the big picture, in its place with all the other pieces, then we'll understand its meaning and purpose.


In the same way, let's withhold our judgments on the War in Afghanistan. We may be tempted to wonder if it all was a waste. But I assure you, it was not. It met its objectives. It prevented further acts of terrorism in America. And, viewed from a more informed perspective, we'll see that it was a critical conflict in the great struggle between good and evil.

**PRAYER:** Dear Father in heaven, the survival of our nation or any nation has never depended upon the opinions of the majority, but on the sacrifices and courage of the few. Please, dear God, continue to raise up men and women of faith and courage who are willing to confront and destroy the oppression of the wicked. Without their faithful contributions our nation cannot survive. We ask this in Jesus' holy name, Amen.



## Have Power Chairs will Travel

In 2012, I received a telephone call out of the blue from the ICU at Mather VA Hospital asking me to visit a Vietnam veteran Marine who had been in the ICU for two weeks refusing food, water and medical attention. After this telephone call I contacted some other veterans I knew to meet me at the hospital for a visit to this veteran. When we all arrived, we filled this nine by twelve room and found this veteran laying on his side. During our visit he turned onto his back and inquired who we were. Before long he requested a glass of water. A few minutes later, a Nurse walked into the room with a tray of food and then a second Nurse walked in and seeing what had been going on inserted an IV into this veteran's left arm. On my next visit with this veteran, I found that he was placed in a room with a second bed and at the same time I found him feeding himself. This is how I got started volunteering at the chaplain's office at Mather VA Hospital.

One day, while I was volunteering, I overheard someone say that the Veterans Administration (VA) does not accept any used medical equipment. A few days later I was in the volunteer's office when someone answered the telephone saying the VA does not accept used power chairs from anyone.

In July 2017, I was talking to a veteran at the hospital and the subject of a power chair he had at his residence came up. This power chair belonged to someone in his family who had passed away. At that time, I made an appointment with this same veteran to bring his power chair to the parking lot at the hospital and he helped me transfer this chair to my pick-up truck. When I unloaded the power chair at my residence, I found this power chair operational.

A few days later I received a telephone call from Glenn Jackson an employee at Mather VA Hospital asking me to see him the next time that I was at the hospital. Several days later I visited with Glenn in his office and was told the hospital had received a complaint from a veteran and asked me to take care of it.

I contacted the veteran and was told he was from the East Bay area and had gone to the VA


hospital located in San Francisco for a medical appointment. During this appointment he was told he had a medical problem with both of his legs and needed surgery to remove at least one of them. After the surgery in San Francisco, removing his left leg, he was told to go to Mather VA hospital for rehabilitation. When he went to the Mather VA hospital, he received a yellow wheel chair and was sent on his way. After he left this hospital, he then discovered he was having problems moving around and contacted the Mather VA. During his next appointment the rehab people gave him a broomstick to help him move around. At this time, he decided to write a few letters complaining about the treatment he had received.

During my telephone call with this veteran, I told him that I had a power chair and would like for him to take a test drive to see if he wanted it. Upon testing out the power chair at his

home I noticed that he was crying.

The next time I was volunteering at Mather VA Hospital I asked the Volunteer Services Office employees to give me all the telephone calls regarding power chairs/scooters.

This was the beginning of my effort to provide donated power chairs and scooters to any needy, disabled or hospitalized veteran. It has been a rewarding experience knowing I have helped veterans. I would like thank VFW Post 1487 and MOC Pup Tent #69 for paying all of the repair bills on these power chairs and scooters. So far, we have been able to help 93 different veterans and counting...




